# Prior to the Summit we were asked to answer the following questions:

1) What is the most important step the ONMS can take to improve our relationship with recreational fishermen?



# 1) What is the most important step the ONMS can take to improve our relationship with recreational fishermen?

Most prevalent response: Enhanced outreach and communications with recreational fishermen.

Better lines of clear, continuous communications.

Improve and expand outreach and education, using printed materials, social media and one-on-one discussions to outline the role of the sanctuary program in relations to recreational fishing activities. Take action to prove that the OMNS will not support a proposal for no-take or restricted-take MPAs within or without sanctuary boundaries. Take notice that they exist, listen to their concerns and improve their fishing experience.





# 2) What are the top three issues of concern for recreational fishermen in your sanctuary?



## 2) What are the top three issues of concern for recreational fishermen in your sanctuary?

Most prevalent responses: Fishery access, fear of future restrictions. Role of sanctuaries versus other jurisdictional bodies in managing fisheries. Scientific information on fish community health and population assessments.

The sanctuary advisory council process and the role of recreational fishing representatives; awareness of sanctuary conservation practices; research collaboration opportunities; perceptions about recreational fishing in sanctuaries; defining high-quality recreational opportunities on a sanctuary; recreational fishing outreach activities.



# 4) A successful outcome of the Summit would be...a realistic plan for the future, including anticipated actions.

## **Summary of Discussion**

 Some of the priorities of recreational fishermen and sanctuary management needs can be specific to each region and national marine sanctuary.

• Fishing access and opportunity are priorities for recreational fishermen whether in a national marine sanctuary or elsewhere in the U.S. Exclusive Economic Zone.





## **Summary of Discussion**

- A common, but not universal perception among recreational fishermen is that marine protected areas, including national marine sanctuaries, take away more (i.e., have more restrictions) than they actually give back (i.e., benefits).
- NOAA needs to improve the dissemination of information, communication and receipt of input from recreational fishermen throughout specific processes including management plans, research, and regulatory activities, etc.





## **Summary of Discussion**

 NOAA and recreational fishermen should explore opportunities to collaborate on science and education projects throughout the national marine sanctuary system.

 There is broad interest in working together to enhance the recreational fishing experience in national marine sanctuaries.





### Commitments

NOAA and recreational fishermen are committed to improve recreational fishing. Our first steps include:

- ONMS will develop and distribute a draft "action plan" based on input from the Recreational Fishing Summit and continue this discussion with recreational fishing representatives.
- ONMS and NMFS will coordinate on Cooperative Research Program activities in national marine sanctuaries.





### Commitments

- Director will contact each site superintendent to ensure there is an ongoing dialogue between recreational fishing representative(s) on all management issues or areas of concern.
- ONMS Director will identify a Point of Contact (POC) at each site for recreational fishing concerns and the POC will establish contact with NMFS regional recreational fishing coordinators.





### Commitments

 ONMS and NMFS Recreational Fisheries Initiative will seek additional regional and national level opportunities for intraagency collaboration and with recreational fishermen based on the output from this meeting.

# Draft ONMS Recreational Fishing Action Plan and MBNMS Implementation

- 1. Increase Opportunities for Engaging Rec Fishermen on Advisory Council
- Establish regular meetings between rec fish council members and Superintendent (or POC)
   ONGOING
- Sanctuary Staff should support rec fish council member outreach efforts regarding site activities and issues - TBD





## 2. Improve Understanding of Sanctuary Management Plan Regulations

- Create summaries or one-pagers that clearly describe action plans and regulations
  - ONGOING
- Facilitate engagement and increased attendance of rec fishermen at sanctuary meetings and events - TBD





# 3. Enhance Rec Fishermen Contribution and Understanding of Sanctuary Science

- Involve rec fishermen in development of Condition Report - TBD
- Provide opportunities for rec fishermen to get briefed on the science supporting management decisions - TBD



### 4. Expand Rec Fishing Programs

- Consider certification programs to partner with rec fish businesses - TBD
- Develop ways for fishermen to report and/or record what they are seeing and experiencing on the water (i.e. marine debris, algal blooms)
  - TBD
- Partner on events such as fishing photo contests, kids angling workshops, etc. - TBD
- Help promote trainings and workshops (i.e. fish handling, barotrauma) - TBD
- Promote rec fishing in visitor centers and outreach booths - ONGOING



## 5. Improve Communications with Rec Fishing Communities

- Support Fishermen in the Classroom Program – ONGOING
- Communicate successes with partnerships and events - TBD
